### About the Jackie Nitschke Center

#### **Our History...**

Beginning as a halfway house known as the Samaritan House in 1973, the Jackie Nitschke Center has evolved into an intensive, continuous and personal substance abuse treatment facility reaching out to the individuals and families of Wisconsin. The facility was named after Jackie Nitschke, the wife of former Green Bay Packer Ray Nitschke. She was a recovering alcoholic and outspoken advocate of alcohol/drug awareness and recovery in the community. Our staff follows Jackie's beliefs while providing comprehensive, well-rounded care. Our hope is that clients and families who suffer from addictions will begin the journey to having a better quality of life by receiving treatment at the center. Each year, we treat over 250 clients in our Residential and Intensive Outpatient programs, with many more still seeking assistance. We are continuously working to improve our services and positively impact the community.

#### A Counselor's Perspective...

HOPE, hope is defined as: "A desire of some good, accompanied with an expectation of obtaining it, or a belief that it is obtainable; an expectation of something which is thought to be desirable; confidence; pleasing expectancy." That definition does not begin to illustrate the power, the miracle, of the Jackie Nitschke Center. Clients enter the Jackie Nitschke Center emotionally, spiritually, and mentally bankrupt. They enter with fear, doubt, and very little love for themselves. Through individualized treatment plans, individualized care, a holistic approach to healing, a team of dedicated professionals who care for each client personally, and the idea that each client can become the person they were meant to be – a seed is planted. A seed of HOPE. A seed that breeds the possibility of a life with no strings attached, a seed that contains respect and pride, a seed that fuels self love. The Jackie Nitschke Center begins each client's treatment with the idea that things can change, that each person is worth the effort, and that each person was put on this earth for a reason. The Jackie Nitschke Center offers far more than a black and white definition of HOPE; we offer the opportunity to live it.





### **Residential Treatment**

In 2010, we provided *3,454* days of care to *154* clients.

### Of the 154 clients...

...82% completed treatment

...81 were male, 73 were female


...the average age was 39

...90 had no insurance, 64 had insurance

...67% of women completed treatment, 80.5% of men completed treatment

...42% were single/never married, 27% were married, and 31% were separated, divorced or widowed

...32% were employed, 57% were unemployed, 11% were retired or disabled







# **Residential Treatment**

98% felt there was a sense of community in the program.

99% of clients felt they learned about responsibility and self-discipline in the program.

99% of clients felt they made progress towards their goals.

90% of clients felt the counselors help clients develop confidence in themselves.

92% of the clients felt they received personalized attention in treatment.








# **Intensive Outpatient and Aftercare Treatment**

In 2010, the Jackie Nitschke Center provided Intensive Outpatient treatment to a diverse population of **181** clients.





Intensive Outpatient say a significant change in funding sources in 2010.

In 2009, 75% of clients paid for treatment directly out of pocket.


In 2010, this number decrease to 25%.


This decrease is attributed to our active involvement in joining insurance networks.





In 2010, the Jackie Nitschke Center experienced a dramatic shift in our payer sources. Unlike prior years, our primary referral source was self-pay clients or clients with insurance.







**Highlights** 

#### **Community Building**

We went out into the community to educate hospitals, the Employee Resource Center, and employers on addiction and the services of the Jackie Nitschke Center. We also participated in health fairs, educated social workers in emergency rooms, did interviews for students, and made contacts with many new people!

We were an active participant in planning the Celebrate Recovery Picnic for National Recovery Month.

In September, we held an Open House with special guests, Gary Knafelc, Chuck Lane, Pat Cochran, Dave Robinson and Royce Boyles, who autographed copies of the book "The Lombardi Legacy" by Dave Robinson & Royce Boyles.

#### <u>Technology Upgrades</u>

In May, we were fortunate to be able to install a new telephone system, a full computer network and computers, and a credit card machine. All have improved efficiency and allowed us to focus more directly on our work with clients.

#### **Sharing Our Experiences**

NIATx came to the Jackie Nitschke Center to interview staff about our experiences with process improvement – which will be used for their 2010 Annual Report.

Darryl Wheeler continues to serve as a peer mentor for STAR-SI. He also served on the planning committee for the NIATx and SAAS National Summit, held in July 2010.

Bill LaBine continues to serve as a coach for STAR-SI and is on the STAR-SI management team.

Rose Maloney and Bill LaBine were one of several agencies to assist NIATx in writing "The NIATx Third-Party Billing Guide."





### Highlights

#### Continued Growth with STAR-SI

We continued our involvement with the STAR-SI program, including improving our services with the following change projects:

- Increasing Self-Pay Admissions in Residential Treatment
  - Increasing Admissions to Intensive Outpatient
  - Increasing Continuation in Intensive Outpatient

#### **Staff Professional Development**

Becky Pasterski earned her Clinical Substance Abuse Counselor certification. Joy Salzwedel earned her Substance Abuse Counselor certification. Mike Thurk earned his Substance Abuse Counselor certification. Hillary Adelman was hired as a Residential counselor.

We mentored interns from University of Wisconsin – Green Bay and Lakeland College. We also meet with Bellin College of Nursing students several times a semester to provide education on addiction.

Bill LaBine, Executive Director, was able to attend the 2010 NIATx and SAAS Annual Summit of behavioral health care providers in Cincinnati, Ohio.

Counselors focused on enhancing case management skills. Clinical team became more creative in individualized treatment approaches.

#### Agency Professional Development

We were able to start providing assessment and individual counseling services.

Jackie Nitschke Center staff worked diligently throughout the year to update agency Policies and Procedures, as well as to enhance client forms for efficiency and consistency.

All levels of care have utilized client satisfaction surveys to assist with programming changes.

We became a preferred provider for several networks of insurance, increasing our funding options.

#### Alumni Group

Our Alumni Group continues to remain a strong, active part of the Jackie Nitschke Center. They held two parties this year – the Summer Fun Party and the Gratitude Party – to bring together clients from all levels of care and celebrate life in recovery.

Alumni members continue to share their stories of experience, strength and hope with current clients through co-chairing meetings, speaking, Big Book meetings, and contact calls.

Several Alumni members volunteered to assist in some remodeling in the center.
